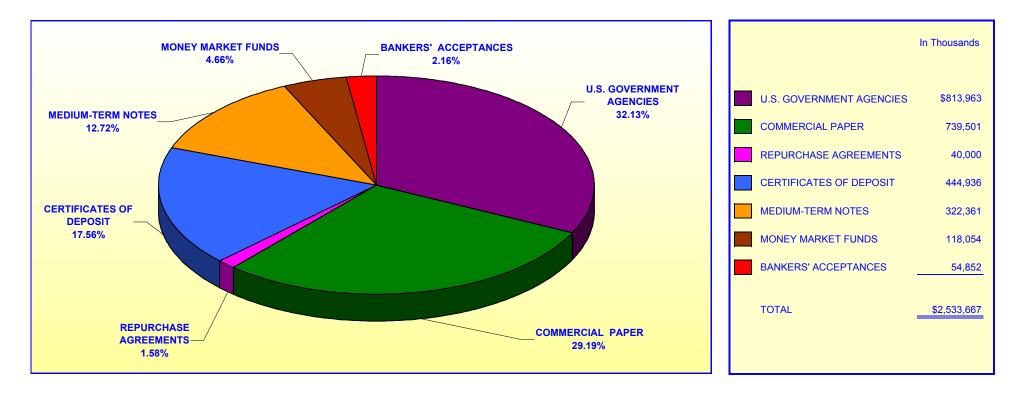

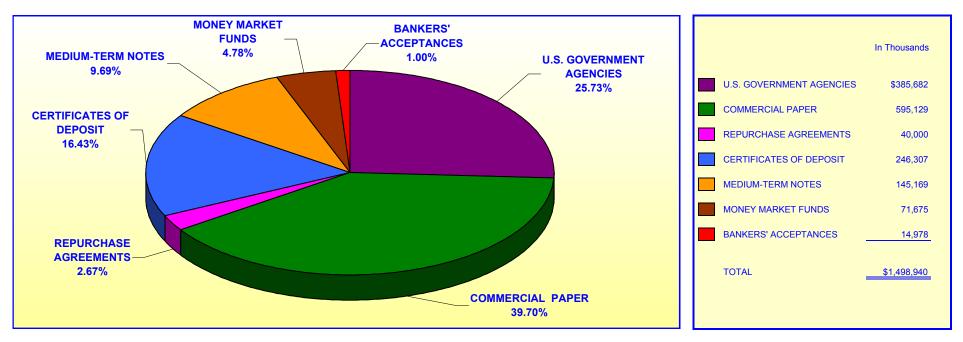

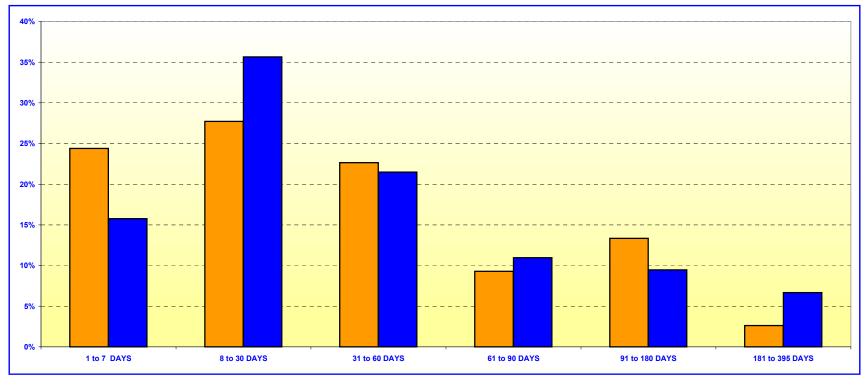

January 31, 2002

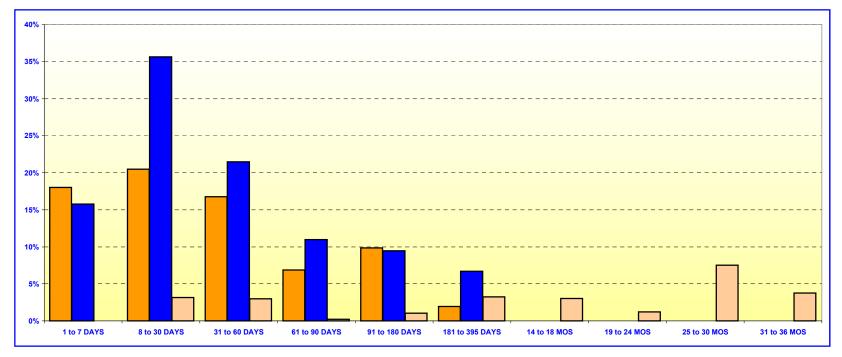

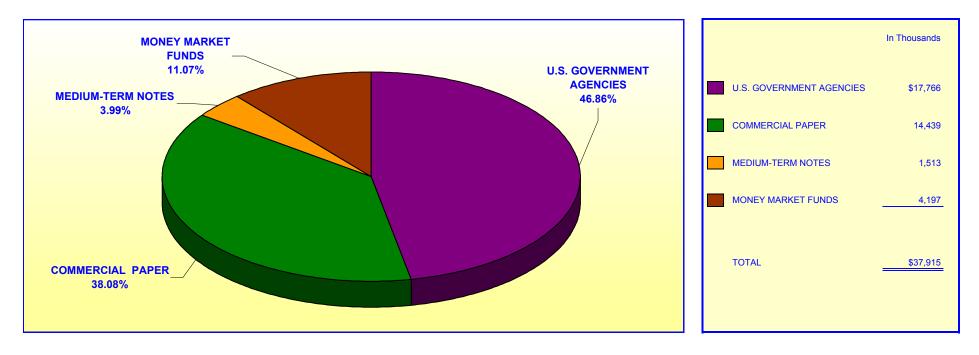

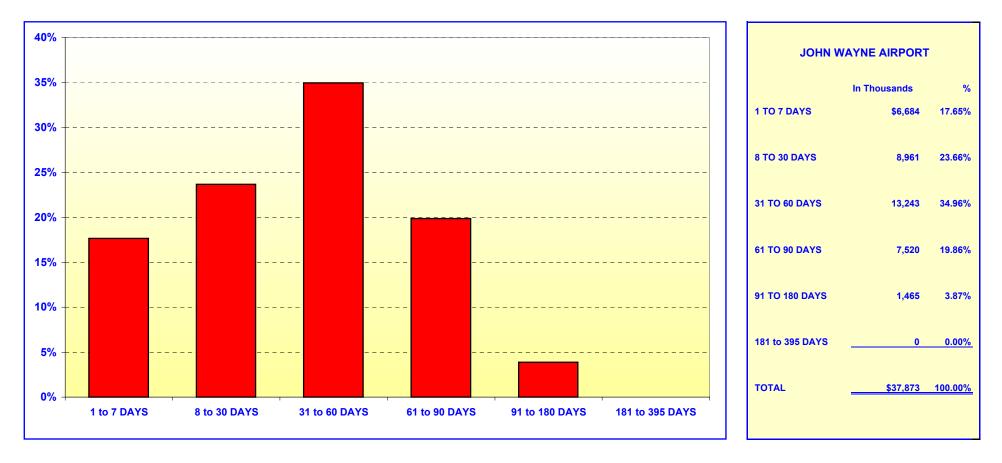

MATURITIES DISTRIBUTION AT COST

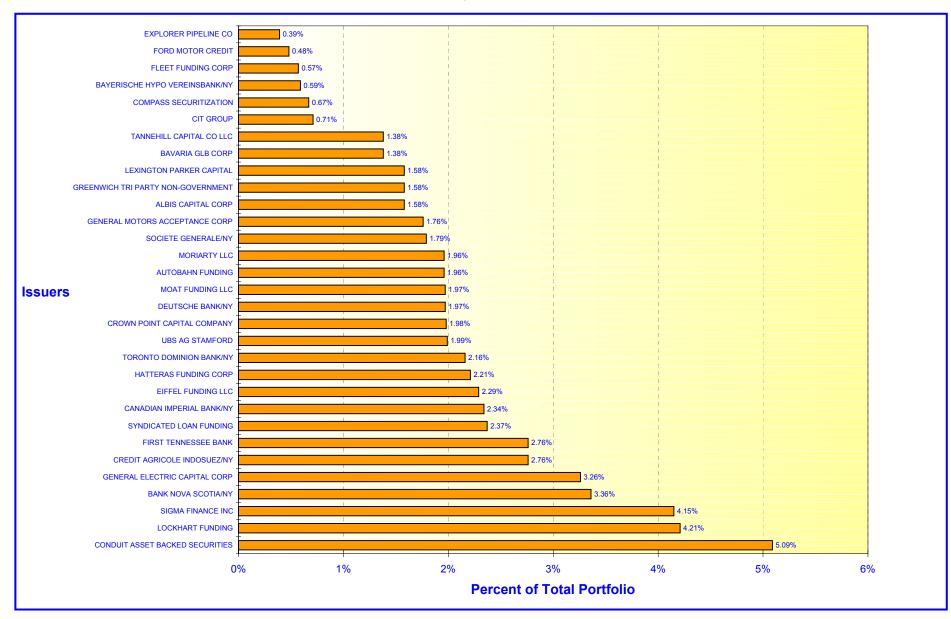

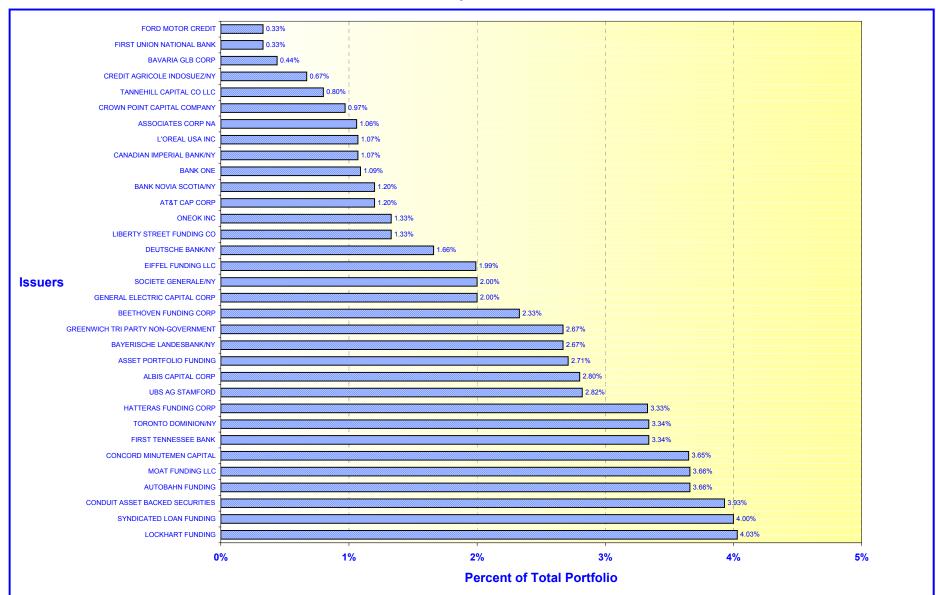
