## Orange County Treasurer-Tax Collector Noncompliance Report Summary For the Month Ended May 31, 2007

During May the County, Educational, John Wayne Airport, and Children and Families Commission Investment pools all were free of noncompliance incidents. Although certain Investment Policy Statement (IPS) guidelines were temporarily exceeded during the month in both the County and Educational Pools, the Treasurer believes they did not cause any material impact of a negative nature.

#### **Technical Incidents**

#### **County Investment Pool**

The percentage of overall portfolio holdings for a single issuer exceeded 5 percent of the market value of the portfolio:

O4-20 A reduction in the Pool's total assets on April 20, 2007 increased the holdings of Barclays Bank PLC NY to 5.11% of the market value of the portfolio. The Treasurer has decided to hold this security until its maturity on June 13, 2007. This will bring the percentage of overall holdings for a single issuer back within IPS limits.

### **Educational Investment Pool**

The percentage of overall portfolio holdings for a single issuer exceeded 5 percent of the market value of the portfolio:

- O5-29 A reduction in the Pool's total assets on May 29, 2007 increased the holdings of Kitty Hawk Funding Corp. to 5.01% of the market value of the portfolio. The Treasurer has decided to hold this security until its maturity on June 7, 2007. This will bring the percentage of overall holdings for a single issuer back within IPS limits.
- O5-31 A reduction in the Pool's total assets on May 31, 2007 increased the holdings of Barclays Bank PLC NY to 5.37% of the market value of the portfolio. The Treasurer has decided to hold this security until its maturity on June 4, 2007. This will bring the percentage of overall holdings for a single issuer back within IPS limits.
