- d) The Treasurer distributed an Attorney General Opinion regarding the composition of Treasury Oversight Committees.
- e) The Broker-Dealer list will be reduced following a review.
- f) The Treasurer distributed a CDIAC opinion clarifying recent legislation to suspend investment reporting requirements.
- g) Assistant Treasurer Dick Hilde's retirement reception will be held December 18<sup>th</sup> at the Treasurer's house.
